3. The organization run by the trust There will be a additional member in the school management committee whose appointment will be done by Director Education.
4. The School run by the trust must reserve 10% seat for the meritorious scholars of schedule caste and Tribe and the levied fee would be in accordance of guidelines issued by the Uttar Pradesh Madhyamik Shiksha Parishad/Basic Shiksha Parishad Uttar Pradesh.
5. The organization run by the trust shall not demand any kind of aid from state government and the affiliation from Madhyamik Shiksha Parishad/Basic Shiksha Parishad Uttar Pradesh shall stand cancelled automatically from the date on which the organization gets affiliation from central Board of secondary Education, New Delhi.
6. In the School run by the trust Teaching and Non Teaching staff shall be provided the same remuneration as the respective staff of state government/government aided educational institutions.
7. Employees shall have stipulated service clauses and shall be provided with the same retirement benefits as employees of Non-Government senior secondary schools.

1. 5. The EMBLEM of the Trust shall be decided by the Trustees in due course during the Executive Committee Meeting.

6. AIMS AND OBJECTIVES OF THE TRUST ARE AS UNDER:

- i. Organizing events, religiously, in which messages for sustaining peace in the society is delivered.
 - ii. To do all acts for eradicating hunger and poverty and malnutrition, promoting preventive healthcare and sanitation and making available safe drinking water.
 - iii. To provide education by establishing Schools, opening of Industrial Training Centers, Vocational Colleges, Professional Colleges and thus create employment opportunities for the disabled, orphans and economically backward sections of people. Prominence will be given to Rural Part of the Society.
 - i. To provide a platform for all performing ARTS.
 - ii. To arrange training camps and workshops by famous ARTISTS and EXPERTS involved in the respective forms of performing Arts to create interest and motivate the younger generation.
 - iii. To provide financial assistance to the needy and meritorious.

 8. Working Hours of the Office will be from 10.30 AM to 6.00 PM with suitable intervals.
 9. Administrative Year of the Trust will commence from 1st of April and end on 31st of March of the next year.

"PROPERTY OF THE TRUST"

10. The Property of the Trust shall include:
 - i. Such contributions, donations, endowments, settlements made by the public, government, institutions etc., for the purpose of advancement of AIMS and OBJECTIVES of the Trust.
 - ii. Such acquisitions and accretions to the Estate of the Trust.
 - iii. A sum of Rs 11000/- (Rupees Eleven Thousand Only) donated by the Settlor. Total amount collected is Rs 11000/- (Rupees Eleven Thousand Only)
11. The Properties, the assets, effects funds and other things of the Trust shall vest upon trust in the Trustees perpetually and irrevocably for the due fulfillment and effectuation of the objects and purpose of the "YUG CHARITABLE TRUST".
12. Subjects to the provision of Para 12 here below, the aims and objects of the Trust will be additionally:
 - i. To conduct, promote or patronize through instruction and education of public opinion or to assist in promotion or conduction of activities for the better understanding of the same.
 - ii. To spread or assist in spreading education including physical and moral training.
 - iii. To provide or assist in promoting the understanding of history, art, literature, music, dance and other cultural forms of India and conduct or assist in conducting research in these fields, public results thereof.

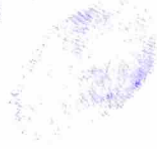

- iv. To establish or run or assist in establishing or running libraries, resource centers, training centers, schools, museums, research institute cultural schools (i.e. music, dance, Drama, art etc.) As well as medical centers and other relief centers for general public utility.
 - v. To permit the use of movable or immovable properties and assets of the Trust without profit motive by institutions whose objectives are similar to the objectives of the Trust.
 - vi. To conduct or assist in conducting activities of art music dance, drama, folklore, literature scientific and charitable nature to all or any of the objects of the Trust and for the achievement of the objects mentioned herein.
 - vii. To acquire by lease, purchase, gift, mortgage, license as beneficiary under any other Trust or otherwise lands, properties, machinery etc., from Government or semi-Governmental authorities, trusts and corporations, institutions and societies as well as individuals to sell, alienate, gift lease mortgage manage or in any other legal manner transfer properties belonging to the Trust and also to give the same on lease or license for the furtherance of the objects of the Trust.
 - viii. To raise secured or unsecured loan from any schedule Bank or any other financial institutions or firm or individuals or as any other institutions including any registered society or trust with or without interest whenever necessary for furthering of objects of the Trust.
 - ix. To receive voluntary donations in cash and kind from any individual or associations for the purpose of carrying out the objects of the Trust.
 - x. To support and render financial assistance to charitable and educational causes and institutions, organizations (companies) trust, societies or individuals in the form of donations, loans or otherwise on such terms and conditions as the Trustees deem for and proper which in the opinion of the Trustees would help to carry out all or any of the objects of the Trust.
 - xi. To give scholarships award, stipend, honorarium to such individuals who have devoted themselves and render their valuable service in cultural educational social and various other public causes.
 - xii. To put up suitable buildings or other constructions to maintain, alter and equip them suitably with machinery and other things and to the discretion of the Trustees to permit their use on lease or license to institutions or organizations devoted to the objects which are similar to those of the Trust.
 - xiii. To offer monetary assistance by way of donations or otherwise render help to mitigate the hardships caused to the general public on account of floods, famine or other natural calamities.
 - xiv. To do all such things as the Trustees may think proper and necessary for the attainment of the above subjects.
 - xv. The benefit of the Trust shall be open to all people irrespective of caste, creed and religion.
 - xvi. The funds and the income of the Trust shall be solely utilized for the achievements of its objectives and no portion of it shall be utilized for the payment to the Trustees/Members by way of Deposit, profit, interest, dividends etc.
13. Trustees are hereby authorized to start or acquire any business with the sole object of applying the profit of such business for the following purpose only:
- i. Relief of the disabled widows, orphans, old age people and economically backward class people of the society.
 - ii. Education to the disabled orphans, widows and economically backward class people of the society.
 - iii. Medical relief to the disabled, widows, orphans, old age and economically backward class people of the society.
 - iv. To run cultural centers to conduct or to assist in conducting all cultural forms by means of performances, exhibitions training workshops seminars, symposiums, museums, libraries and resource centers.
14. The Management of Trust shall be vested in the Board of Trustees, constituted by the Trustees mentioned herein above from Sl.No. i. to v, who shall be first Board of Trustees.

15. THE TRUSTEES ARE AUTHORIZED TO CO-OPT ADDITIONAL TRUSTEES. IT IS HEREBY DECLARED THAT THE MAJORITY OF TRUSTEES HAVE POWER TO WIND UP THIS TRUST BY MERGING OR AMALGAMATING WITH ANY OTHER TRUST OR CHARITABLE SOCIETY HAVING SIMILAR OBJECTS, IF THE TRUSTEES SO DECIDE THAT THE OBJECT OF THE TRUST WOULD BE BETTER SERVED BY TAKING SUCH A STEP.
16. The assets, properties and income and other things of the trust shall not be applied for any purpose other than the purposes and objects of the Trust and such application shall be in strict accord with the specific provisions made there in the deed and subject strictly to the provision of clause II in the Deed.
17. The Trustees have power to frame such subsidiary rules of the business and shall have power further, to alter, add or amend the same from time to time as may be necessary for the conduct of their business not inconsistent with the provisions of sections 80 (G) of the Income tax Act 1961. the rule in schedule 'A' hereto shall be the first body of such rules and same shall be in force until substituted, altered, added or amended from time to time as the case may be by the Trustees.

ARTICLES OF TRUST

1. CANCELLATION OF TRUSTEESHIP:

The Trustee

- i. Who is convicted (Imprisoned) by any Judicial Court in India.
- ii. Who has become insolvent legally.
- iii. Who is entangled / indulged in any criminal case also
- iv. Who is suffering from mental disorder and in case of death of a trustee.

Such Trustee is liable for ineligibility and his Trusteeship will be cancelled.

2. BOARD OF TRUSTEES:

Board of Trustees will be having an initial batch of Trustees to the extent of six only, further extendible upto 10.

3. ANNUAL MEETING:

Annual meeting will be held by the end of April every year.

4. SPECIAL MEETING:

IN CASE OF INSISTENCE BY TWO THIRD (2/3) MAJORITY OF TOTAL TRUSTEES, THE MANAGING TRUSTEE SHALL CALL FOR SUCH SPECIAL MEETING.

5. QUORUM

Two third majority of the total trustees is required for each meeting. However in case of inadequate quorum at the time of stipulated meeting, the meeting can be postponed for another half an hour only, and then can be conducted irrespective of quorum, subject to discuss the matters as per AGENDA.

6. ANNUAL REPORTS:

The audited statement of accounts, annual reports and budgets shall be presented at the time of Annual meeting for necessary verification and approval.

7. DUTIES OF BOARD OF TRUSTEES:

- i. At least once in a month meeting should be conducted by fixing a suitable date and time.
- ii. Quorum required is as per Para 5 above and the same condition are also applicable here.
- iii. Trust is responsible for all moveable and immovable property.
- iv. In case of cancellation of membership of any Trustee for the reason whatsoever it may be the trust, which can elect or co-opt other suitable person to that place.
- v. The trust shall verify all applications for trustee and appropriate action.

- vi. The trust is empowered to have the help and co-operation of the State Government Central Government, other association Organization and public in general through the managing Trustee with the help of other Trustees.
- vii. Action in connection with any matters shall be enforced and after getting approval during the meeting.

8. DUTIES OF THE MANAGING TRUSTEES

- i. The Managing Trustee shall preside over the meeting and see smooth and successful meeting is conducted.
- ii. He shall take active participation for each and every work as a leader and see that every work is done without any obstruction.
- iii. He shall look after the entire letters correspondence of the trust.
- iv. In case of equal majority while casting the vote, irrespective of the matters, the Managing Trustee is empowered to cast his vote for deciding the issue, which is final and binding on all the Trustees.
- v. All financial transactions inclusive loan, financial assistance from any institutions.
- vi. pertain to the Trust must be dealt with by the Managing Trustee with the help & co-operation of any other Trustee.

9. AUTHORISATION TO MANAGING TRUSTEE:

In the interest of smooth and better functioning of the Trust, the Managing Trustee is hereby authorized to undertake the following.

- i. The Managing Trustee shall look after the letters correspondence.
- ii. He shall send, or arrange to send notices of meetings to all the Trustees in time.
- iii. He shall release amount for each and every program duly maintaining the amount with relevant documents properly.
- iv. He shall get the statement of accounts audited every year and obtain the approval during the annual meeting.
- v. He shall prepare annual report and budget and get the approval from the annual meeting.
- vi. The Managing Trustee is empowered to purchase or legally acquire any land/buildings etc. required for the Trust.
- vii. He is empowered to avail any type of help and co-operation from the Government or general public or any other association organization in the interest and welfare of the Trust.
- viii. He is empowered to represent the Trust in all the fields and can keep any letter/document in his possession.
- ix. He is empowered to appoint person/persons for the post(s) created so as to attend day-to day work of the Trust and also to take action legally against any employee of the trust.
- x. Totally he is responsible for each and every matter or correspondence.
- xi. He shall prepare all the accounts and maintain registers of the Trust and get them approved during every meeting.
- xii. He shall operate the financial transactions in any Nationalized Bank in the name of the Trust only.
- xiii. Amendments to Memorandum of the Trust and Articles of the Trust can be proposed by the Trustees as and when required.



10. Special clause for CBSE School.

- i. The organization run by the trust There will be a additional member in the school management committee whose appointment will be done by Director Education.

11. INVESTMENT CLAUSE

The fund of the Trust shall be invested in the modes specified under the provisions of section 13 (1) (d) read with Section 11(5) of the Income Tax act 1961 as amended from time to time.

12. ACCOUNTS CLAUSE:

All accounts of the Trust shall be maintained regularly. The accounts shall be audited by a CHARTERED ACCOUNTANT every year. The accounts shall be closed by 31st of March every year.

13. AMENDMENT CLAUSE:

No amendment to the Trust deed/memorandum of Association Bye-laws rules and regulations, shall be made which may prove to be repugnant to the provisions of section 2 (15) 11, 12 and 13 and 80 G of the Income Tax Act 1961 as amended from time to time. Further, NO AMMENDMENT SHALL BE CARRIED OUT WITHOUT THE PRIOR APPROVAL OF THE COMMISSIONER OF INCOME TAX.

14. DISSOLUTION CLAUSE:

In the event of dissolution or winding of the trust, the assets remaining as on date of dissolution shall under no circumstances be distributed among the trustees/members of the managing committee/Governing body, but the same will be transferred to another Charitable Trust/Society whose objects are similar of those of this Trust and which enjoys recognition under section 80 G of the Income Tax Act 1961 as amended from time to time.

15. The Trust formed shall be irrevocable.

16. The benefits of the Trust shall be open to all irrespective of caste creed and religion.

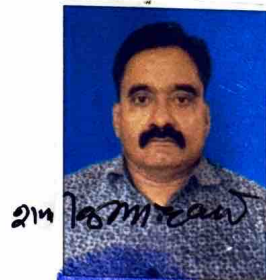
